# Meredith's Story.

Meredith knows the fear that comes with an ovarian cancer diagnosis. Even now, as a survivor, moments of uncertainty still creep in. Diagnosed with Stage 1A ovarian cancer, she was fortunate to catch it early - but knows that many women aren't as lucky. **With only 46% surviving beyond five years, research and awareness are more crucial than ever.**

Her journey began with an unexpected pain during a Pilates class, dismissed at first as gluten intolerance. But her colleagues urged her to see a doctor - advice that likely saved her life. Within two weeks, she was in surgery, facing the reality of ovarian cancer. Six rounds of chemotherapy followed, ensuring no lingering cancer cells remained.

Meredith's experience has fueled her determination to give back. A scientist at the University of the Sunshine Coast, she understands how challenging medical research funding can be. By leaving a gift on your will, you'll be supporting women like Meredith.

# Simple Ways to Make a Lasting Impact.

There are several ways you can leave a Gift in Will to Cherish. Each offers a meaningful way to support women's health and create a lasting legacy:

- **A percentage of your estate** – ensures your gift remains in proportion to your estate's value.
- **A specific amount of money** – a fixed dollar amount that suits your wishes.
- **The residue of your estate** – the remainder of your estate after other gifts and expenses are covered.
- **Assets** – such as shares, real estate, or other property.

# It's Easy to Make a Difference.

Leaving a Gift in Will to Cherish is a powerful and straightforward way to create lasting impact.

Here is suggested wording you can share with your solicitor:

*"I give [insert your chosen gift] to Cherish Women's Cancer Foundation (ABN 86 158 553 229) for its general charitable purposes. I declare that the receipt of the authorised officer of the Foundation shall be a full and sufficient discharge to my executors."*

You're not required to inform us of your decision, but if you feel comfortable, we'd love to know. It helps us plan for the future - and gives us the chance to say thank you.
